### **“Design Your Own Paper Bag Owl” GUIDELINES**

1. The entry form must be received by April 6, 2012. This competition is for Little Sweethearts and Bluebelles. Each child may enter only One (1) owl.
2. The objective is to design your own owl using a paper lunch bag.
3. Paper Bag Owls can be decorated with anything (glitter, beads, ribbon, jewels, etc.) It must be distinguishable as an owl. **Be creative!**
4. Please allow the girls in your group to express their own ideas, creativity and artwork. **Guide them, don't do it for them!** Bluebelles will compete against other Bluebelles, and so forth. (The judges will determine if it is the girls' work.) **PLEASE NOTE ANY OWLS DECORATED BY ADULTS WILL BE DISQUALIFIED.**
5. Owls will be judged throughout the day. Judges will score each category on the following scale:  
**1=Fair      2=Good      3=Very Good      4=Excellent      5=Superior**
6. Owls must be checked in at the designated table during registration.
7. **Each Owl should be taken home by the participant at the end of the day.**
